Message from the Chief Executive Officer



The year 2020 will be remembered for many things, but largely for the economic and health challenges faced globally. Saskatchewan was not immune to these challenges. We lost businesses, economic momentum and saddest of all, we lost citizens. While many of our lifestyles and business practices changed dramatically and will never be the same, there were some positive lessons learned.

Of all the lessons I learned in 2020, the most prevalent was the value of Chambers of Commerce in Saskatchewan. When the COVID-19 situation fully came to light in March, the Saskatchewan Chamber of Commerce staff and Board of Directors transitioned overnight to serve the needs of our members in a completely new and critically important way. We immediately began phoning members to ask them how they and their businesses

were doing. We provided input to our provincial and federal governments on programs and supports that businesses desperately needed. We did everything we could to inform the Saskatchewan business community of the available support programs through our website and social media channels to ensure that businesses had all they required to sustain their operations. Throughout the remainder of the year, we continued to advocate to and consult with governments, listened to our members, provided input, and communicated outcomes so clear information was easily accessible to our membership.

Even with our daily activities transitioning towards COVID-19 recovery, I am very pleased to report that we maintained our strategic focus on areas of long-term importance. In January of 2020, we launched our Indigenous Engagement Charter with over 200 people attending the ceremonies. The Charter now has 46 Signatories and many committed investors supporting the efforts of this important program. More than 1,300 people took part in our Indigenous Awareness Training program in the last year, through virtual training technology. We also launched an Indigenous Business Directory as an online procurement tool for all to use.

Thought Leadership was another strategic priority of ours and we did plenty to support this initiative

throughout the year. We hosted webinars with experts on COVID-19 related programs as well as broader economic issues like our *Small Business, Big Pivot* session with RBC's John Stackhouse. The provincial election provided an opportunity for the Chamber to communicate our key issues, which we did with great success. The election results suggest the people of Saskatchewan want certainty in their elected leadership and Premier Scott Moe's win has delivered that.

We enter 2021 with the strength of our strategic plan in place, with an expanded staff complement of exceptionally skilled individuals and with a Saskatchewan chamber network that is stronger than ever. We celebrated our 100th anniversary in 2020 in a quieter than anticipated manner, but in 2021 we will proudly celebrate our century of success and most importantly, the start of an even more successful century. We will do this as we always have, by working together with our members, with our governments, and with a clear focus on making Saskatchewan a better place to live, work and invest.

COVID-19 and the SCC Response

The ongoing COVID-19 pandemic has presented our members and their communities with extreme personal and economic challenges. In our role as a member-based business organization, we are fortunate to have a direct line to our over 600 member businesses. During the first three months of the pandemic, Saskatchewan Chamber of Commerce staff worked primarily from home carrying out critical dayto-day functions in the following areas: internal and external stakeholder engagement, research, and advocacy. Below is an overview of the SCC's actions in those areas.

INTERNAL AND EXTERNAL STAKEHOLDER ENGAGEMENT

Member Calls

The first weeks of the pandemic involved staff calling members to see how they were doing, asking what they required from us, and informing them about available government support programs.

• Business Association Calls

SCC actions included phone calls with Saskatchewan local chamber managers weekly; Provincial chamber CEO and Canadian Chamber CEO weekly calls; joint provincial/territorial - Canadian Chamber weekly policy lead calls; and SCC CEO – Board of Director weekly calls.

SCC Website & Social Media

The SCC created a new section on its website with useful information on program support specifics that are updated on a regular basis. Our extensive social media presence was also harnessed to circulate information on new support programs, along with good news stories from businesses doing positive things for their community.

• Thought Leadership Hub Series

A virtual series of moderated discussions with members on select topics. Topics included the Saskatchewan economy, trade expansion, the low carbon economy, the commercial real estate sector, lessons learned, Indigenous engagement, and consumer confidence. The Thought Leadership Hubs were sponsored by RBC and Knight Archer Insurance and took place from September to December 2020 with plans to continue throughout 2021.

• COVID-19 Member Surveys

The SCC circulated to members a series of COVID-19-themed surveys throughout the summer of 2020. Surveys included an initial Business Impact Survey in March, Current State of Business Survey in April, and COVID-19 Program Support Uptake Survey in July. Information gleaned was used to inform our policy positions.

• Saskatchewan Business Council

Ministry of Trade & Export

• Online Webinars

The SCC hosted webinars involving both Provincial and Federal Ministers. Notable SCC webinars included one with federal Minister Mélanie Joly and another with provincial Minister of TED Jeremy Harrison. SCC staff also participated in third-party webinars to gain greater insight and offer a Saskatchewan business perspective.

RESEARCH

Federal & Provincial COVID-19 Actions to Date

Ongoing tracking of business sector relevant actions enacted by provincial and federal levels of government. Information was circulated to members via e-mail and social media.

COVID-19 International Response Backgrounders

Circulated two backgrounder documents to members. One provided an overview on COVID-19 business sector supports across English speaking countries and the other provided an overview of public health and macroeconomic policies enacted across advanced economies.

Consultations with Commercial Real Estate Members

SCC staff circulated a survey and engaged one-on-one with select commercial real estate landlords and owners. Feedback solicited was used to inform recommendations around the now-defunct Canada Emergency Commercial Rent Assistance



(CECRA) program. Consultation findings were summarized in an article, *The Impact of COVID-19* and Commercial Landlord – Tenant Cashflow Challenges published on the SCC website in May 2020.

 Guidelines for Re-Opening Office Environment Workplaces – SCC staff developed workplace guidelines to ensure the heath and safety of staff and guests while in the office. Guidelines also included a return-to-work process. These guidelines have been revised regularly and adopted by several other chambers and business organizations.

ADVOCACY

Some of our key COVID-19-related advocacy work to date included written submissions to:

- Minister of Parks, Culture, and Sport Gene Makowski urging the Province to keep the Saskatchewan Provincial Parks Registration System open during COVID-19 in March 2020.
- Then-Finance Minister Bill Morneau requesting the federal government extend the eligibility for various business support programs to Indigenous-owned businesses in April 2020.
- Prime Minister Justin Trudeau recommending that temporary sick pay coverage be included under the Canada Emergency Response Benefit (CERB) in May 2020.

- Minister of Labour Relations and Workplace Safety Don Morgan in May and September 2020 advocating for a time extension afforded to employers to provide notice to furloughed employees during the COVID-19 public health emergency order.
- Minister of Energy and Resources Bronwyn Eyre offering considerations on the design of a program intended to promote the clean up of orphan and inactive oil and gas wells located in the province. Considerations were developed in conjunction with members operating in the oil and gas industry.
- Premier Scott Moe recommending improvements to the CECRA program and the establishment of a temporary moratorium on commercial rental evictions during the entirety of the Public Emergency Order in June 2020.
- Premier Moe communicating important considerations and support for the province's tourism and hospitality sector in the context of Re-Open Saskatchewan.
- Minister of Health Jim Reiter recommending an independent review of the long-term care system and the need to include private sector operators in such a review.
- Creating and advocating to the Province a long-term recovery and resilience plan. SCC CEO, Steve McLellan, has been leading a committee of the Saskatchewan Business Council on this initiative.

CURRENT STATUS

We are happy to report that our research and advocacy efforts have paid off. At the federal level, then-Minister Morneau enacted changes that expanded program eligibility for Indigenous-owned businesses: the federal government, after winding down the CECRA program, created an entirely new and improved commercial rent assistance program based on feedback from our members: Minister Morgan has thus far enacted temporary layoff provisions during the public health emergency order that have been largely consistent with our advice; and the Ministry of Energy and Resources has largely took heed of our program design considerations regarding the province's orphan and inactive oil and gas well clean up program (Accelerated Site Closure Program).

While we anticipate working on elements of the COVID-19 file well into the foreseeable future, at this point in time we have largely transitioned our day-to-day operations back to other programs to help support our members and the larger Saskatchewan business community. We must remain vigilant around COVID-19 and be prepared to respond accordingly. In the meantime, we will continue to emphasize to businesses the need to follow the Re-Open Saskatchewan guidelines and to maintain positivity throughout their internal and external communications.

Saskatchewan Business Council and Government Communications During COVID-19

The Saskatchewan Business Council (SBC) was formed in 2017 to serve as a point of connection between key provincial business groups to share ideas, program insights and discuss government relations. The SBC is an independent collection of like-minded associations and other business support groups mandated to:

- Promote the positive contributions of Saskatchewan's business community;
- Proactively inform and advance ideas on common priorities that enhance the competitiveness of Saskatchewan's business climate;
- Collaborate on providing feedback or consultation to government on business-related issues; and

 Be a vehicle to share relevant information with colleagues to further both the Council's priority items and individual advocacy efforts.

While the conversations were always productive, this past year has shown the immense value in connection and communication for Saskatchewan CEOs, as the SBC served as a strong conduit for government to gain and communicate information around the pandemic.

The 18 regularly participating groups represent key private sector associations across Saskatchewan. The SBC had regular calls with the Minister and Deputy Minister of the Ministry of Trade and Export

Development. These conversations provided a collective process to provide input and for all the organizations to hear of issues or upcoming changes depending on the week and the issue.

The ability to gain insight from sector experts provides the Saskatchewan Chamber of Commerce with a broad and valuable perspective. While nothing replaces face-to-face conversations with our members, it is a very useful dedication of the SCC's time. The SBC was formed by Derek Lothian of Insurance Brokers of Saskatchewan, Mark Cooper of Saskatchewan Construction Association and Steve McLellan of the Saskatchewan Chamber of Commerce.

Canada United Campaign





Canada United is a nationwide initiative created by RBC in collaboration with chambers of commerce and companies from across Canada to support local businesses in communities across the country.

The initiative kicked off with the Canada United Weekend contest, where local business supporters across the country were encouraged to share their shop local stories for a chance to win one of 25 \$10,000 prizes.

The Canada United Small Business Relief Fund (CUSBRF) was established to help small businesses offset the cost of expenses to reopen safely or adopt digital technologies to move more of their business online. So far, over \$14 million has been contributed by the Federal Government, RBC, and

Canada United partners to support recovery efforts due to COVID-19. Grants of up to \$5,000 were awarded to businesses who needed to purchase personal protective equipment, renovate their spaces to adhere to guidelines, or develop or improve e-commerce capabilities.

With the help of our local chambers of commerce, the Saskatchewan Chamber of Commerce helped spread the word throughout the province to ensure that Saskatchewan businesses were taking advantage of this valuable support program. During the first phase of this program, 100% of the funds allocated to Saskatchewan were claimed, and in February 2021, additional contributions allowed the fund to re-open and begin accepting new applications.

\$14 Million has been contributed by the Federal Government, RBC, and Canada United partners to support recovery efforts due to COVID-19.

Canada Shop Local




In November 2020, the Saskatchewan Chamber of Commerce was invited to apply for federally supported "Shop Local" funding, intended to amplify and build on the existing Shop Local efforts run by local chambers across the province.

Staffed local chambers of commerce in Saskatchewan were then invited to apply to the SCC to access this federal funding to support Shop Local initiatives in their communities, strengthen local economies, support local employment opportunities, and ensure that small businesses can compete and thrive in a post-pandemic economy. The program was also available for those chambers looking to launch new Shop Local activities.

Chambers applied for funding through a simple application process and provided an overview of planned activities. Chambers also had the opportunity to present their own unique activities that also aligned with the Shop Local initiative. Activities such as video promotion, online marketplaces and advertising campaigns will help local businesses throughout the province access a greater number of customers.

The Shop Local activities are set to begin in Spring 2021 in communities across Saskatchewan.

Grab Your Slice





Grab Your Slice was a series of webinars hosted by MNP and the Saskatchewan Chamber of Commerce aimed at helping Saskatchewan businesses apply for Federal COVID-19 support programs. There were many companies and non-profit organizations that had not accessed funding due to a lack of awareness or knowledge on the various programs available and their respective application processes.

In Fall 2020, reports from the Federal government on the Canada Emergency Wage Subsidy (CEWS) program indicated that Saskatchewan businesses only accessed approximately 1.7% of the allocated dollars through the CEWS program alone. With Saskatchewan

having 3.11% of the Canadian population that meant Saskatchewan businesses were shorted by approximately \$185 million and in some cases, time was running out for Saskatchewan businesses to access CEWS and other Federal support programs.

This motivated the Saskatchewan Chamber of Commerce to partner with the experts at MNP to deliver a free webinar series that provided Saskatchewan businesses with a step-by-step walkthrough of the application processes for CEWS and other COVID-19 financial support programs. A province-wide, multi-faceted advertising campaign resulted in over 500 registrants across 10 sessions and the general consensus was that the session was

informative, easy to understand, answered attendee questions, and that the facilitator from MNP, Josh Shankowsky, was knowledgeable and well organized.

The Chamber would like to thank the Government of Saskatchewan and participating local chambers of commerce for their support on this initiative as well as the the experts at MNP for their valuable partnership that helped more Saskatchewan businesses get their slice of the pie.



Building the Low Carbon Economy: Exploring Opportunities and Challenges for Saskatchewan

Throughout 2020, one of the largest efforts undertaken by the Saskatchewan Chamber of Commerce, outside of the pandemic, was the development of the report Building the Low Carbon Economy: Exploring Opportunities and Challenges for Saskatchewan, which was publicly launched in March 2021. The purpose of this report was to provide leadership on the transition to the low carbon economy by developing a body of knowledge that could inform the Saskatchewan business community, all levels of government, and the general public. By identifying business-related opportunities Saskatchewan will not only survive, but thrive while meaningfully contributing to decarbonization efforts.

The SCC's thought leadership efforts on the low carbon economy file included the *Energy Series* tours and programming (a series of discussions on energy-themed topics). These conversations were coupled with eleven expert written submissions, private stakeholder consultations, and an extensive research effort to the develop the *Building the Low Carbon Economy* report.

As a business organization, the SCC was able to offer a unique vantage point on this issue. The SCC membership is broad-based and diverse, encompassing individual businesses and industry associations that operate in high emissions

activities such as oil and gas, mining, manufacturing, and trucking and rail freight transport, in addition to low emissions activities such as clean energy and professional and technical services. As such, the report based its recommendations on the best interests of the broad Saskatchewan business community.

At the conclusion of consultations, the SCC accepted three assumptions: the move to a low carbon economy is inevitable in Canada; decarbonization efforts will have very uneven impacts across stakeholders; and the Saskatchewan business community cannot successfully transition to a low carbon economy alone.

Building on these assumptions, the report contains 18 recommendations focused on how the provincial and federal government can support Saskatchewan businesses striving to achieve climate change goals. These recommendations focus on preserving competitiveness, regulatory certainty, diverse energy production, strategic investments in energy efficiency, more Indigenous participation in energy production, reskilling and transitioning workers, and simplifying funding requirements for businesses seeking support.

Credit Elections Saskatchewan

Election Pillars & Actions Taken

In advance of the 2020 provincial election, the Saskatchewan Chamber of Commerce released a set of election pillars and policy recommendations that informed Chamber members of key business issues for the election, put business priorities in front of political parties, and raised the profile of these issues in the public.

The policy recommendations were grouped under the following pillars:

Economic Recovery

Recommendations centered around business competitiveness, a comprehensive review of the province's tax system, and investment in public-private partnerships to improve the province's broadband infrastructure.

Financial Literacy

Recommendations included making the Financial Literacy curriculum mandatory for Grades 11 and 12 in secondary schools across Saskatchewan, developing Financial Literacy curriculum for Grades 7-10, training teachers in the curriculum, and creating a distance education course.

Energy Efficiency and the Low Carbon Economy

Recommendations included using revenue from the province's technology fund to promote energy efficiency, promoting the increased uptake of clean energy sources like wind and solar, removing barriers to encourage growth in non-utility

scale, distributed energy generation systems, and encouraging the development of small modular nuclear reactors (SMRs).

Labour Markets

Recommendations centered around ensuring the importance of essential skills and experiential learning are communicated with all relevant ministries, engaging with underrepresented segments of the workforce, collaborating with post-secondary institutions and private industry in the development of curriculum, incorporating more STEM and digital learning opportunities into the K-12 curriculum, and creating a framework for modular, stackable micro credentials.

Trade Diversification and Supply Chain Resiliency

Recommendations included collaborating with the federal government to pursue trade diversification by allocating more resources toward emerging, highgrowth economies, continuing to assess the province's supply chain-related risks in the post-pandemic era, and hedging against future international trade-related risks by working with the federal government to reduce and/or remove internal trade barriers.

Government Procurement

Recommendations centered around operationalizing the provincial government's newly revised

government procurement policies by prioritizing Saskatchewan-based vendors, adopting minimum safety standards for any vendor working on a provincial government contract, and investing capital in both the hardware and software that will help generate the data necessary to inform long-term decision-making around major capital projects.

Indigenous Engagement

Recommendations included developing a whole-of-government Indigenous engagement strategy, incorporating Indigenous procurement guidelines into a larger procurement strategy going forward, and creating incentives for non-Indigenous vendors to partner or sub-contract with Indigenous vendors when bidding on work.

Leading up to the election, the SCC released a series of videos highlighting the importance of these pillars and the corresponding recommendations to government. Videos featured local business leaders from across the province, including Ryan Urzada (The Atlas Hotel), Eric Dillon (Conexus Credit Union), Dean Clark (Greenwave Innovations), Tracy Arno (Essence Recruitment). Evan Doepker (Doepker Industries), Thomas Benjoe (FHQ Developments), Val Sluth (Praxis Consulting), and Monica Kreuger (Global Infobrokers).

While the Deputy Minister Virtual Reception was a success, we are looking forward to returning to an inperson event very soon.



Indigenous Engagement Charter Launch and Current State



In January 2020, the Saskatchewan Chamber of Commerce launched its Indigenous Engagement Charter (IEC) at First Nations University of Canada in Regina and at the World Trade Center in Prairieland Park in Saskatoon.

The Indigenous Engagement Charter was developed with expertise and cultural sensitivity and aims to bring Saskatchewan's Indigenous population to the same economic level as the broader population by enhancing engagement among Saskatchewan businesses. Both Indigenous Engagement Charter launch events started with traditional female and male pipe ceremonies, along with a formal grand entry. We were joined by guest speakers and the Honourable Russ Mirasty, Lieutenant Governor of Saskatchewan.

The Saskatchewan Chamber of Commerce secured 20 early signatories to the Charter and we celebrated their commitment to creating an Indigenous engagement strategy during the launch. Signatories of the Charter are working to create an operational three-year Indigenous engagement strategy. The areas of focus while creating an internal strategy include, but are not limited to recruitment and retention, procurement and supply chain diversity, community engagement, and investment. The strategy can concentrate on some or all of these areas depending on the capacity of the organization.

Once signed, each signatory receives a sample strategy template and sample metrics document to track their progress. Additionally, the SCC team will then provide ongoing support and review each signatory strategy once submitted. The goal is to ensure that all signatories are dedicated to creating a strategy, but also to identifying how they plan on operationalizing the strategy over the three-year period.

Another supplementary tool provided to signatories to support their engagement efforts is a step-by-step process that can assist companies as they begin or continue their strategy action plans. The SCC's goal is to ensure that the Indigenous communities, people, and Indigenous-owned businesses have the same level of access to

training, jobs, advancement, and participation in our economy. We understand the social and economic benefits that occur in our province for all its citizens when Indigenous people have an equal say in the direction the economy will go. We have received several draft and complete strategies and have seen some positive steps taken to enhance overall Indigenous engagement across the business sector in Saskatchewan.

After the unprecedented year we all experienced, we are happy to report that we have secured 26 new signatories in 2020, which brings the total to 46 charter signatories. The SCC team remains steadfast in our efforts and as we move forward into 2021, we are determined to support all our signatories as they work towards actionable goals that will lead to increased overall Indigenous engagement.

Indigenous Awareness Training



In 2020, the SCC embarked on several new projects to enhance Indigenous engagement for Saskatchewan businesses, including the launch of an Indigenous Engagement Charter, the creation of an Indigenous-owned business directory, and offering several levels of Indigenous Awareness Training.

Sponsored by Nutrien and led by SCC Director of Indigenous Engagement Nick Crighton, the SCC's Indigenous Awareness Training sessions are designed to inform members of the business community about the culture and history of Indigenous peoples in Saskatchewan.

Level 1: Myths & Misconceptions

This introductory session covers the history of Saskatchewan's First Nation & Métis peoples from precontact to today, including Treaties and the TRC Calls to Action.

Level 2: Implementing an Indigenous Strategy & Hiring/Retention for Business

This advanced session covers how to implement an Indigenous strategy for your business as well as information on hiring and retaining Indigenous employees.

Level 3: Indigenous Protocols & Cultural Traditions in Saskatchewan

This advanced session provides an in depth look at how to interact with Indigenous senior officials, Elders and Knowledge Keepers. 100% of the registration fees for Level 3 training are donated to the Saskatchewan First Nations Veterans Association.

In March 2020, the SCC partnered with John Lagimodiere of ACS Aboriginal Consulting Services to offer online webinars as an alternative to in-person sessions. As a result, the SCC has seen a

substantial increase in registrations and is reaching a broader audience throughout Saskatchewan. In 2020, the SCC saw over 1,300 registrations, representing over 100 businesses in the province, and issued almost 500 Certificates of Participation.

allow for increased engagement
between members of the
Saskatchewan Chamber of
Commerce and Indigenous-owned
businesses in the province.

The SCC's Indigenous Engagement Charter was launched in January 2020 and serves as a road map to provide businesses with tools to achieve engagement and assists the business community in demonstrating the role it must play in reconciliation. The Indigenous Business Directory is an important addition to the resources offered by the Indigenous Engagement Charter and is a valuable tool for businesses that want to meaningfully engage with the Indigenous business community in Saskatchewan.

The Indigenous Business Directory focuses on Indigenous-owned businesses, defined as 51%+ Indigenous-owned, and includes verified and non-verified businesses. The online portal allows for businesses to set up a profile and

provide additional information such as locations, services offered and contact details. Businesses in the directory have been contacted and encouraged to claim their profile and update all details. Adding verified Indigenous-owned businesses to the directory will open up the market and provide an opportunity for more connections to be made.

The SCC is encouraging all Saskatchewan businesses to use the Directory in their procurement and partnership plans. By doing so, businesses will gain quality suppliers and help the overall economy grow.

Chamber Accreditation Validates Strong Chambers of Commerce



Did you know?

Employers who work in a mandatory industry* in Saskatchewan must have a WCB account under *The Workers' Compensation Act, 2013* (the Act).

An employer is anyone who hires one or more workers either on their payroll or on a contract basis.

Contract situations are present in all industries. An invoice from a business or an individual is considered a contract. Generally, this means that you must report all persons or businesses that you pay but do not carry on your payroll.

Responsibilities

- ✓ Register your business within 30 days of hiring a worker either on payroll and/or on a contract basis.
- ✓ Report your total gross payroll for all workers and contract labour by Feb. 28 annually.
- ✓ Request a clearance on all workers who you do not carry on your payroll.
- ✓ Report a work-related injury to the WCB within five days of being made aware.
- ✓ Pay your annual premiums on time.

*Mandatory industries are defined under the Act. Excluded industries and occupations are listed in Part II of the Act (farming and ranching) and in *The Workers' Compensation Miscellaneous Regulations* (all other excluded industries).

In the midst of the COVID-19 pandemic, the Saskatchewan Chamber of Commerce was inundated with questions from businesses often pertaining to newly announced government programs. People needed help and often were not sure where to turn.

Many of these companies were longtime Chamber members who had come to rely on the Chamber for assistance over the years, while others were new to the Chamber and feared for the survival of their business. For those companies, the work of a provincial Chamber of Commerce was foreign to them. Unfortunately, at this stage of business uncertainty and with revenue prospects bleak, the last thing many were in a position to do was make a financial commitment to a Chamber membership. In the interests of the broader

provincial economic recovery, the decision was made to launch a six month, no cost Trial Membership Program. This allowed companies to avail themselves of the benefits of the Saskatchewan Chamber of Commerce while continuing to focus on the economic well-being of their business.

As the six-month period draws to a close, we are pleased to have helped approximately 50 Saskatchewan businesses. Trial members have engaged in several Chamber programs, actively supported programs via sponsorship and in almost all cases, made the most of this opportunity.

Renewals are beginning now and it is clear the vast majority of these businesses will convert to regular Chamber memberships.

"A rising tide lifts all boats" is an expression often referenced in terms of Saskatchewan's economic recovery. We are proud that the Trial Membership Program will have helped several Saskatchewan businesses navigate the troubled waters during this difficult time in our province's history.

There should be greater emphasis on investing in energy efficiency, technology, and innovations because these would result in effective ways to quickly and permanently reduce baseload energy needs.

The SCC Environment Committee was established in 2002 to address issues arising from environmental policy that affect business operations in Saskatchewan. The Committee regularly meets for discussions, often with senior government officials in attendance, and develops policy resolutions.

The past year has resulted in lots of movement on the environment file at both the provincial and federal levels. For example, the federal government announced Canada's Strengthened Climate Plan in late December to achieve net-zero emissions by the year 2050, which included the significant raising of the carbon tax to \$170 per tonne by 2030 and a Clean Fuel Standard. The ambitious plan will have many impacts on the competitiveness of our industries and the associated cumulative costs will continue to

increase. We are certainly moving towards a low carbon economy, but we will still need our traditional oil and gas sector to meet our energy needs during this transition. There should be a greater emphasis on investing in energy efficiency, technology, and innovations because these would result in effective ways to quickly and permanently reduce baseload energy needs. The SCC actively continues our research and advocacy efforts on this file.

The SCC extends many thanks to Bob Schutzman for his years of dedicated service as the Chair of our Environment Committee. We welcome Jessica Theriault as our new Chair and look forward to her direction. Our Environment Committee continues to be active advocates for the interests of our business community.



Thought Leadership Hubs

The Saskatchewan Chamber of Commerce launched a new Thought Leadership Hub series in 2020 with support from RBC and Knight Archer Insurance. The series began in September 2020 and brought together business leaders from across Saskatchewan.

During the nine events in 2020, over 150 businesses came together to exchange ideas, experiences and sometimes, frustrations, all contributing to providing solutions on a wide variety of topics. The discussion topics and the Thought Leadership Hub concept itself grew from the hundreds of calls SCC staff made to members during the early days of the COVID-19 pandemic. Each Hub began with an expert who was responsible for framing the conversation and open discussion on shared experiences and big ideas followed. Many new business relationships were formed from these sessions and participants indicated they are looking forward to continuing the discussions on a new range of topics in 2021.

The session covered a five-point plan to help small businesses remain solvent and exit stronger from the pandemic. Following the presentation was a panel where SCC members Alisha Esmail of Road Coffee Co. and Shawn Moen of 9 Mile Legacy Brewing joined John to talk about the big pivots they have made in their respective businesses. The Energy Series was created in 2019 by the Saskatchewan Chamber of Commerce to support Saskatchewan's oil and gas industries, explore energy innovation and promote energy efficiency. Given the COVID-19 pandemic, we transitioned the Energy Series to be a set of engagement sessions held in conjunction with SaskPower with a focus on electricity options and plans for sustainable power systems. The online engagement sessions took place with Chamber members in Regina, Estevan and Prince Albert with plans to continue the series in 2021 to additional communities.

The guest lists were curated to include municipalities, small businesses, large businesses, those interested in self power generation, Indigenous communities that generate power and more. During the sessions, SaskPower provided an overview on the current state of power in Saskatchewan and described to guests what the future of power could look like.

The topics covered in these sessions not only covered power itself, but also addressed environmental considerations, Indigenous participation and

economic development in Saskatchewan. And while solar power, nuclear power, and green energy was discussed; the focus was on what a sustainable power system means to you.

We are looking forward to many more conversations like these in our 2021 Energy Series, which will include expert panel discussions, casual Q & A sessions, and energy related content aimed to educate Saskatchewan on the importance of our energy sector.





Training and Employment Network



In response to the COVID-19 pandemic, the SCC developed the Training & Employment Network (TEN) to provide support to communities and companies to integrate Indigenous, immigrant, youth, and women workers into the local workforce.

The TEN is funded through Western Economic Diversification Canada (WD) and administered by the SCC. Through the TEN, participating chambers receive up to \$10,000 in funding to develop and implement a Community Action Plan that identifies gaps in regional labour markets and creates opportunities for employers and workers. The intent of the TEN is to provide clear and locally coordinated pathways for workers to be identified, as well as

to present learning opportunities to enhance skills using a combination of existing and new training for employers.

The TEN is specifically targeted to underrepresented groups including Indigenous peoples, women, gig workers, youth workers (ages 18-24), students (under 18), and newcomers (in Canada less than 5 years).

In October 2020, the Chamber network circulated a survey to businesses across the province to identify current labour demands by region. Using localized survey analysis, chambers of commerce are working to develop and implement action plans specific to their communities.

Saskatchewan's chambers of commerce play an integral role in the TEN through:

- Leading all stakeholders in order to work together toward an enhanced labour market. The chamber role is to act as an employer convener, an ecosystem coordinator, an employer educator, an experiential learning coordinator, a pathway designer, a data provider, and a fundraiser. It is key that employers see value in the TEN as this will determine its progress.
- Aligning a workforce training and education system that matches underrepresented workers with employer-driven demand.
 Workforce alignment is the idea that every community has different silos and by using chambers of commerce to bring efforts together and align growth together, we avoid duplicating results and work towards a common goal.
 Ultimately, the chamber role is to align people, processes, and systems.
- Connecting people to employers and training based on skills.

Regional chambers of commerce participating in the TEN include Battlefords, Estevan, Humboldt, Kindersley, Lloydminster, Moose Jaw, Nipawin, Prairie Sky (Warman & Martensville), Prince Albert, Swift Current, Weyburn, and Yorkton.

The recruiting tools empower businesses to target job opportunities to candidates based on skills, experience, education, certifications, and diversity requirements.

The platform allows users to reach job seekers from more than 85 postsecondary institutions across Canada and assists employers in accessing the financial supports available for student hiring through the Student Work Placement Program (SWPP). The platform also assists employers in building more inclusive and equitable workplaces, and enables diverse and inclusive hiring with tools that target LGBTQ candidates, newcomers, persons with disabilities, Indigenous persons, women, and visible minorities. Magnet includes

access to business growth information from Export Development Canada, Business Development Bank of Canada, Global Affairs Canada and the Future Skills Centre.

The SCC Magnet platform is available on the Saskatchewan Chamber of Commerce website and is open to all Saskatchewan businesses.


