Introduction

The Achieving Business Excellence (ABEX) Awards are the highest award for Saskatchewan business. The ABEX Awards have been celebrating the success of businesses and business leaders across the province since 1984.

The ABEX application process will be done entirely on an online platform. You can access your account as many times as you need to until the application deadline on June 24, 2022. You may apply for one or many award categories.

Any applications that are not complete and saved by the deadline will not be accepted. Applications must be completed online. Award recipients from previous ABEX Awards cannot re-apply for the <u>same category</u> within 3 years of receiving the award, but they can apply for other categories. ABEX Business of the Year recipients cannot re-apply within 5 years of receiving the award.

Judging Process

The application deadline for the 2022 ABEX Awards is June 24, 2022. All completed applications are forwarded by the Saskatchewan Chamber of Commerce to an independent auditing firm. The auditing firm may be in touch with applicants for additional information.

The auditing firm scores each application using a scoring matrix. Once the application forms have been analyzed, a judging meeting is called in mid-August. Here, a group of independent judges – business leaders, representatives from post-secondary education institutions, and past-Chairs of the Saskatchewan Chamber of Commerce, review applications, debate the merits of each application and vote.

The judges select three finalists per category. The ABEX finalists will be announced shortly after the judging through a province-wide media release and on ABEX social media channels. The judges will then select one winner per category from the finalists. Winners will be announced to the public during the in-person ABEX Awards event on November 5, 2022. ABEX finalists are expected to attend the in-person event. A live stream of the event will be available on Vimeo and Facebook.

The ABEX Business of the Year will also be announced during the ABEX Awards. The winner of this coveted award is chosen out of the winning applicants, with the decision based on the overall application as well as some additional information provided by the applicants. All information is strictly confidential.
